


#### 1. PURPOSE

It is not the intention of Knox LAC via this policy to prohibit those with a legitimate interest in recording, filming or photographing children, young people and helpers/officials participating in sport-related activities associated with the Knox Little Athletics Centre (Knox LAC).

The purpose of this policy is:

- To ensure Knox LAC athletes, parents/carers and the Knox Little Athletics Centre have control over the images and recorded data of children/young people, families, officials and all associated with Knox LAC
- To deter unsuitable people/persons from misusing sporting activities to obtain images or recorded data of Knox LAC athletes, parents and helpers/officials.
- To prevent unsuitable images or recorded data of Knox LAC athletes and parents, helpers/officials or inappropriate representation of the sport from being produced.
- To protect the identity of Knox LAC athletes and helpers/officials who may be made (to feel) vulnerable or compromised through the publication of their photos or personal details.
- To provide identification of registered Knox LAC photographers who record and photograph Knox LAC sporting events on a routine basis.
- To define processes for professional and student/amateur photographers to obtain permission to record Knox LAC sporting events
- To ensure all Knox LAC athletes, parents/carers, helpers, officials (including Knox LAC Executive and Centre & Club Committees) and coaches are aware of these guidelines and accept and agree to abide by the guidelines.
- To ensure athletes and families from other Centres who are attending athletic competitions organised by Knox LAC are aware of these guidelines and accept and agree to abide by the guidelines.

#### 2. SCOPE

The scope of this policy covers all forms of technology that can be used to record audio or video images of Knox LAC athletes, children/young people parents/helpers and Knox LAC coaches & officials involved in sporting activities associated with the Knox Little Athletic Centre.

These technologies include all forms of film-based and digital photography (including video), mobile phone cameras and analogue and digital audio recorders.

#### 3. GOVERNANCE

The Knox LAC Executive will provide overall governance for this policy.

Governance activities include:


- Approval and release of this document and subsequent versions
- Ensure a co-ordinated and documented approach to all aspects of this policy including ownership, accountability and responsibility of all components of the policy
- Provide the final decision in any complaint/dispute either with the policy or as a result of the
  application of the policy including whether or not a complaint/dispute is escalated beyond the
  Knox LAC.
- Provide a focal point for process discussions and communications.

#### 4. LEGITIMATE INTEREST IN RECORDING, FILMING AND PHOTOGRAPHING

"Legitimate interest" in recording, filming and photographing of children, young people and helpers/officials involved in sporting activities associated with Knox LAC covers:

- Parents/carers, siblings and friends who wish to record a child/children participating in a sporting event as a personal memento or as a record of competition
- Officials, Committee members or agreed parents/carers of Knox LAC or associated Knox Centre clubs who wish to record a child/children participating in a sporting event as a memento or record of competition on behalf of Knox LAC or an associated club.
- Registered Knox LAC photographer(s) who wish to record a child/children participating in a
  sporting event to publish on the Knox LAC or associated club websites or maintain as an
  archival record, or to use for athletic promotional purposes on behalf of Knox LAC (and/or
  associated Clubs), Little Athletics Victoria or Athletics Australia.
- Designated Knox LAC coaches and assistants/helpers who wish to record child/children as a legitimate coaching aid. Athletes and their parents/carers are to be made aware that this is component of the coaching program and care should be taken in the storage and distribution of such recordings.
- Professional and student/amateur recording and photography as outlined in Sects 6 and 7 that have been sanctioned and approved by the Knox LAC Executive.

Anyone recording, filming or photographing children, young people, family members and helpers/officials involved in sporting activities associated with Knox LAC must do so as "legitimate interest" and in accordance with this policy.

The Knox LAC Executive and competition officials reserve the right to investigate, question and seek clarification of any persons involved in recording or photographic activities that do not appear to be for "legitimate interest" and/or appear to be in nonadherence to this policy.

In the case of recording and photographic activities not being in 'legitimate interest" and/or non-adherence to this policy the Executive will take appropriate action to stop these activities including removal of those involved in the activities from the complex precinct.

#### 5. PROFESSIONAL RECORDING, FILMING AND PHOTOGRAPHING

Professional photographers/filming/video operators wishing to record Knox LAC sporting events should seek accreditation with the event organisers by producing their club or registration and a letter from their club/company/organisation outlining the motive and reasons for attending the event and recording it.

Professional photographers/filming/video operators who are invited, requested or employed to record Knox LAC sporting events should be from accredited companies or business and either have been or need to be made aware of this Knox LAC policy and agree to act in accordance with the guidelines.

#### 6. STUDENT OR AMATEUR RECORDING, FILMING AND PHOTOGRAPHING


Student or amateur photographers/filming/video operators wishing to record Knox LAC sporting events should seek accreditation with the event organisers by producing their club or registration and a letter from their club/company/organisation/school outlining the motive and reasons for attending the event and recording it. They also either have been or need to be made aware of this Knox LAC policy and agree to act in accordance with the guidelines.

#### 7. ACCREDITATION PROCESS

Professional or student/amateur photographers are to register with Knox LAC prior to the event they wish to record and their identification details and motives for recording the event should be checked and recorded by Knox LAC. Knox LAC reserves the right to refuse permission to photographers who do not supply the required information.

If accredited, on the day of event, photographers are to be issued with an agreed identification label(s) and any other agreed proof of photographic accreditation which must be worn/displayed when the photographer(s) is recording the event. The identification label is to clearly visible on the photographer(s) and should be in the form of a lanyard or lapel badge.

## 8. PERMISSION TO BE RECORDED / PHOTOGRAPHED & REQUESTS NOT TO BE RECORDED / PHOTOGRAPHED

Registered Knox LAC athletes and their families and athletes who register to compete at Knox LAC events and competitions (and their families) are automatically covered by this policy when competing at Knox LAC events (including training).

The submission of athlete registration forms includes the athlete(s) and their families acceptance that they may be recorded and/or photographed in accordance with this policy, specifically for "legitimate interest". As such permission from registered athletes and their families to be photographed (whether intentionally or not) is not required or sought.

If athletes or families (or specific family members) do not want to be recorded or photographed whilst attending Knox LAC events or competitions, they can write to LAVic advising that they do not wish to have recordings or photographs taken of the athlete and or the family. LAVic will provide the athlete / family with a means of identification such a wrist band to be worn during all events. LAVic will also advise Knox LAC Executive Committee of the athlete and requirements to not record or photograph them. Knox LAC is to keep a record of all athletes and/or family members who are not to be recorded/photographed. Officials and photographers are to take this into account during the actual competition.

If an athlete or family has not advised LAVic and do not wish to have photographs or recording on a particular day or competition event, an adult member of the family (or carer) must notify event officials (either when registering or prior to the start of a competition) and provide details as to what athletes/families are not to be recorded/photographed. A brief summary of the reason(s) for not wanting to be recorded/photographed is required for Centre records and to ensure officials and photographers take that into account during the actual competition.

In this instance athletes who are not to be recorded/photographed will be identified by the addition of a red label on their competition patch. This label is to be displayed on the athletes competition patch or wrist band worn for any and all events that they are not to be recorded/photographed in. Knox LAC is to keep a record of all athletes and/or family members who are not to be recorded/photographed.

#### 9. KNOX LAC PHOTOGRAPHERS

The Knox LAC Executive will approve any photographers (including volunteer parents or helpers) who are authorised to photograph and record a child/children participating in a sporting event to publish on the Knox LAC Website or maintain as an archival record or to use for athletic promotional purposes on behalf of Knox LAC and associated clubs, Little Athletics Victoria or Athletics Australia.


Accredited Knox LAC photographers will be required to wear an approved Knox LAC issued "Green Polo Top" with the Knox LAC logo and the word "Photographer" printed on it during photographic activities associated with Knox LAC events.

Persons wishing to be a registered Knox LAC Photographer can make an application to the Knox LAC Executive through by contacting the Knox Photographic Coordinator <a href="mailto:photos@klac23.org.au">photos@klac23.org.au</a>

Any person who wishes to apply must undergo a "Working with Children" (WWC) check and be issued with a WWC card and certificate as a prerequisite for applying for approval and acceptance as a Photographer. This card is to be maintained in a current state and be carried by photographers at all times when photographing and produced when requested.

**Note:** All current Knox LAC Photographers possess current WWC cards. Details on photographer WWC cards are to be made available to the Knox LAC Executive who will maintain this information as part of Knox LAC WWC information and documentation.

Only approved Knox LAC Photographers will be permitted to photograph Knox LAC activities on the infield/centre track. They will remain subject to direction from officials and event organisations and are bound by normal competition rules in terms of ensuring competition is not impeded by their photographic activities.

Non-approved photographers, family members or other athletes are not permitted on the infield/centre track and must remain behind track fences/perimeter boundaries and remain compliant to all relevant aspects of this policy.

Knox LAC ensures that a Photography Coordinator is appointed each season. The Photography Coordinator role is:

- To organise available Knox LAC photographers to ensure the most effective photographic coverage of the competition (including a mix of age groups, genders, events and specific photographic requirements of the competition),
- act as a liaison point with event organisers in terms of event photography,
- ensure this policy is being observed by those attending the event and adjudicating the policy
  if and as required.
- manage the photos posted on the Knox LAC Google Photo account. (See Sect 10 for further details on publishing of audio and video photography recorded at Knox LAC events.).

During Knox LAC competitions Knox LAC Photographers will be rostered on to photographic duty in accordance with a roster. The roster is to be maintained by the Knox LAC Photography Coordinator. This ensures that the running of specific competition events is not compromised through lack of duty personnel being available and that excessive numbers of photographers do not impact on the running of events.

Knox LAC Photographers are to seek permission from the Knox LAC Executive to photograph or record athletes, children or parents/officials associated with non-Knox LAC clubs or centres on a regular basis. This does not include Region or State championships.

#### 10. PUBLISHING OF PHOTOGRAPHIC AND VIDEO MATERIAL


Knox LAC photographers are responsible for sorting their own photos, editing and uploading to the appropriate album in KLAC Google Photos. The Knox LAC Executive reserves the right to edit, modify or delete photography that is deemed inappropriate or portrays athletics or Knox LAC in an adverse or incorrect manner.

The Google Photos albums and the Knox LAC website link will be administered by the Knox LAC Photography Coordinator and may be included as part of an event photo gallery, Knox LAC headlines or to advertise activities associated with Knox LAC. Photos taken at normal Knox LAC competitions will be kept on the Knox LAC Website for the season.

Each Photographer should limit the number of photos uploaded to no more than a maximum of 300 photos. There is no maximum number of photos that can be published for special event days such as Open and Championship Days.

A selection of lower resolution copies of still photographs will be published on Knox LAC Google Photos albums and accessed via a link on the Knox LAC Website to provide a memento of appropriate events. All photos, for publication to Knox Google Albums are to be reduced to a size to assist with storage and accessing speeds. The reduced size should be less than 1MB per photo.

Hi-resolution still photography taken by Knox LAC photographers under this policy is to be stored by the relevant Knox LAC photographer for future reference purposes. Interested persons can apply for hi-res copies of photos as approved by contacting the Knox Photography Coordinator.

If there are multiple events/competitions during a particular week that require photos to be published or linked to the Knox LAC Photography Coordinator will manage photos published on the Knox LAC Website to ensure appropriate events have photographic coverage.

Normal Competition photos will remain as albums on the Knox LAC Google Photos albums for the duration of the associated athletic season. Photos from special events/championships will be kept for 12 months. Following the end of the season, photos will be archived.

Photos published from normal weekly competitions are to be uploaded to the nominated KLAC Google album by 6pm on the following day. If no album has been created the photographer uploading the first batch of photos will create and name the album following normal naming conventions.

Photos from Special Event Days are to be uploaded to the nominated album as soon as practicable after the event. If no album has been created the photographer uploading the first batch of photos will create and name the album following normal naming conventions.

Photos that are uploaded to the Knox Google Albums should be a balance between great shots in general, action shots across as many age groups/genders/event types as possible and some non-athlete/parents' shots if it enhances the ideals of fun, family and fitness.

The above process relating to photos covers normal weekly comps including Twilights. There are no limitations for special events such as Open/Championship Days as well as EMR/State.

Photos may include the persons name and/or age group if deemed relevant to the article or event. The Knox LAC Executive will make the final decision as to publication of a person's name and/or age group.

Under no circumstances will personal details (including address or contact details) will be published with photographs unless specific permission in written form or by email has been obtained from the athlete concerned and their parent/carer and the details published are relevant to the particular photograph/event.


Any photographs copied, transferred, downloaded from the Knox LAC Google Photos albums or Knox LAC Webpage must be in accordance with this policy and must be of an adhoc nature.

Clubs associated with Knox LAC may copy and publish to their own website or to social media a photo(s) copied from the Knox LAC Google Photos albums or the Knox LAC Website as long as the photograph(s) pertain to athletes/events associated with the particular Club and are also of an adhoc nature.

Other Little Athletics Centres and Clubs may publish a photo(s) copied from the Knox LAC Google Photos albums or the Knox LAC Website as long as the photograph(s) pertain to athletes/events associated with the particular Club/Centre and are also of an adhoc nature. Photos published in this manner (including on the internet, websites, social media, or in printed publications) must acknowledge Knox LAC as the supplier of the photos (e.g. "with thanks to Knox LAC for the attached photos"). Knox LAC, in return, will acknowledge other Centres with a similar note, when publishing photos copied from their website or sent to Knox LAC.

All publication of photos or video to social media must be done in accordance with the Knox LAC Use of Social Media Policy. Any questions regarding the use of social media should be directed to the Knox LAC Executive Committee.

#### 11. PUBLIC INFORMATION ON THIS POLICY

The details of the existence of this policy and its application during Knox LAC events is to be, where possible, published in all relevant events programs. The existence of this policy should also be noted in the annual Knox LAC Handbook, made available on the Knox LAC website and whenever athletic-based photos associated with Knox LAC are published on the website.

All athletes and parents/carers are to be made aware of this policy and the following clause is to be part of all Knox LAC registration forms and signed by parents/carers.

"This Club and the Knox Little Athletics Centre may take and use images of athletes in its promotional materials, including Knox LAC Website Newsletters and Annual reports in accordance with the "Knox LAC POLICY and GUIDELINES ON AUDIO AND VIDEO PHOTOGRAPHY AND FILMING" All care is taken that those images are appropriate for the purpose. If you have any objections to your child's image being used please contact a Club Committee Member or the Knox LAC Executive."

If anyone has concerns or issues about any photography or recording during a Knox LAC event, they are to contact the Knox Executive Committee member or the Knox Photography Coordinator. If it is determined by the Knox Executive Committee that inappropriate photography or recording has or is being conducted at a Knox LAC event, the Event Co-ordinator reserves the right to ask the person or persons concerned to leave the event immediately.

This policy is owned and authorised by The Knox LAC Executive and is not to be copied wholly or in part without permission. Permission is to be sought and obtained from Knox LAC Executive by other LA Centres or organisations who wish to use all or part of this policy document as the basis for their own policy.
